- 1. The sponsors reserve the right to accept or reject each application.
- 2. Food Vendors must provide menu.
- 3. <u>Food vendors will need an Amherst County Health Department temporary food vendor permit.</u> Contact Wayne Burnette at the Central Virginia Health District phone number (434) 946-9408 ext. 9589.
- 4. All participants must operate the entire event Saturday (11am-6pm)
- 5. No tables and chairs will be provided. Please bring your own. Vendors will be notified if tents are required; spaces underneath the pavilion are on a first come first serve basis, and are 9'x12'. We recommend tents for outside vendors. Due to VDH restrictions all food vendors will be required to set up outside of the pavilion.
- 6. We are interested in unusual exhibits, activities, and events in keeping with the special Summer Solstice spirit. We welcome your ideas on educational and entertaining programs that could be presented
- 7. Mail your application by March 30 for a reduced fee.
- 8. All accepted applicants will be notified via the mail or email. We will send detailed festival information to applicants as they are accepted.
- 9. <u>THE FESTIVAL WILL GO ON RAIN OR SHINE.</u> All vendors must have a substantial canopy or other protection for themselves. Once accepted, vendor fees are not refundable.
- 10. Liability Insurance: Susceptible vendors (wineries, food, etc.) must provide liability insurance, naming Lazy Days Winery, LLC, and the Virginia Summer Solstice Wine Festival and its staff and underwriters as co-insured.
- 11. Each vendor will be responsible for his/her property. Lazy Days Winery, LLC, and the Virginia Summer Solstice Wine Festival and its staff and underwriters are not responsible for any damage, theft, or loss for any reason.
- 12. Overnight security will be provided by staff. We will have hired security on-site during the festival.
